

LEGAL BASES

FREAK SCULPTURE WARS 2020

This contest is organized by **LA POSADA DEL FRIKI**, non-profit association, and organizer of Freak Wars; with the sponsorship of **Green Stuff World** during the days planned for the annual event **FREAK WARS 2020** held this year in Online format from September 11 to 13, 2020. The contest is aimed at sculpture works.

1. Form of participation

The delivery of paint works will be done **digitally through the website of Freak Wars** in the following [web form](#), under the established conditions in the present bases of participation.

- a) **Any number of both traditional and digital works can be submitted through the official Freak Wars website, with the deadline being Sunday 6 September at 23:59 (GMT+2).**

Works that have been commercialized can be submitted.

- b) Judges, members of the Freak Wars organization, as well as sponsoring brands are excluded from the contest. **Volunteers from Freak Wars**, not being part of the organization, **are allowed to participate.**
- c) The works can be shown in social media by the organization and the press media present at the event.
- d) The works can be reassigned by the jury to the category they consider appropriate.

2. Inscription

- a) **The inscription is free.**
- b) Works **containing only scenographic elements** will not be accepted.
- c) The submission of **works in traditional format** has to be done with the following format:
 - i) **4 photographs in good quality must be taken of each work from the following angles** in order to make a correct evaluation: **front, both sides and back.**
- d) The submission of **works in digital format** has to be done with the following format:
 - i) Black and white image with several views (minimum 6)
 - ii) **Two additional images** with a front view and another to choose from, with shadow calculation (Render). It can be in color or without color.

3. Categories

The **Freak Sculpture Wars** contest has just one modality in which the following formats are included:

- **Digital and traditional modeling:** For the general public. Works must be submitted as indicated in the inscription section. **Works that only contain scenographic elements** will not be accepted.

The works will be eligible for the prize of best modeling and therefore the **Best of Show** award in this contest.

4. Awards

- a) In a first phase, a selection of the most voted works on the Freak Wars website will be made. These works will be the finalists of the competition and will go on to the next phase, in which they will be evaluated by the jury.
- b) The jury will assess each work and make the decision as a whole, assessing the aspects that they consider most important.
- a) The awards ceremony will take place on Sunday September 13 at 17:00 during the live broadcast of Freak Wars 2020 Online.
- b) The prizes to be awarded according to each category will be the following:

3.1 Modeling:

- Venerable Dragon Trophy for each category in gold, silver and bronze. The trophy will be sent to the winners. After the event, the winners will be contacted to send them their prize.
- Raffle of products and/or store vouchers from different brands collaborating with Freak Wars among all participants (excluding the winner of the BoS). The prizes will be raffled by the organization during the weekend of the event. A single participant may not receive more than one single prize. Each eligible participant occurs only one entry in the raffle, regardless of the number of works submitted. The prizes to be raffled are the following:
 - **Green Stuff World:** 50€ voucher for online store

3.2 Modeling - Best of Show (BoS):

- This prize will be unique.
- The winning work will not win any other prize.
- Possibility of being jury the following year.
- Platinum Venerable Dragon Trophy and a 80€ check that will be delivered by bank transfer. The trophy will be sent to the winner. After the event, the winners will be contacted to send them their prize.

5. Jury

a) The jury of Freak Sculpture Wars of Freak Wars 2020 will be formed by the following members, all of them of great recognition in the sector.

b) The decision of the jury will be irrevocable.

5. Fraud

a) The organization reserves the right to exclude any participant from the present contest if there is any indication of fraud.

b) Likewise, the organization reserves the right to withdraw the participation of any contestant in the case of writing or making inappropriate comments prior or during the event.

c) Those participants who use false profiles, false data or other fraud mechanisms to participate in this contest will also be eliminated from the contest.

d) The organization reserves the right to request ID, passport or driver's license to prove the identity of the participants.

6. Causes of force majeure

a) The organization reserves the right to cancel the contest, when causes of force majeure occur that so require, without it being the object of claims of any kind.

7. Modification of the legal bases

- a) The organization reserves the right to make, at any time, any modifications, deletions and/or additions to these legal bases.

8. Acceptance of the present rules and legal bases

- a) The simple act of participating implies full acceptance of these rules and legal bases, leaving the jury entitled to resolve any eventuality not foreseen.
